

F-1 Student Financial Statement

As a student, it is your responsibility to demonstrate that you will have sufficient financial support available to cover all educational and living expenses while studying at PVCC. As an F-1 student, employment options are limited. Therefore, all support must come from one or more of the four areas listed below. Students must maintain access to this amount during their time at the college. PVCC reserves the right to request updated financial statements or support at any time.

This evidence is required to complete an official U.S. government form on which the school official is confirming that financial support is available. Therefore, Piedmont Virginia Community College reserves the right to request additional information or clarification.
